The estimated cost is **Rs 326.00 Million (without VAT)**

The Time for Completion for the whole of works shall be **545 calendar days** from the date of signing of the agreement.

2. Bidding will be conducted through National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements.

The method of payment will be in **cash**.

Bids shall be delivered with a duplicate to the address below **marked referenced number MOD/SLA/07/2018** to the **Chief Accountant, Ministry of Defence, 15/5, Baladaksha Mawatha, Colombo - 03** on or before **1030 hrs on 05.09.2018** Late bids will be rejected. Bids will be opened soon after closing (**on 1030 hrs at 05.09.2018**) in the presence of the bidders’ representatives who choose to attend. Bidders are advised to inform in writing, to the Chief Accountant’s office, Baladaksha Mawatha, Colombo 03 the name and the NIC/ Passport Number of the individual who is participating to the bid opening at least prior to three (03) working days of the bid opening.
8. Bids shall be valid up to **04.12.2018**.
9. All bids shall be accompanied by a *Bid-Security (unconditional on demand Bank Guarantee issued by the bank operating in Sri Lanka, approved by the Central Bank of Sri Lanka)*, of **Rupees Three Million Three Hundred Thousand (Rs 3,300,000/=)** Bid Security shall be valid up to **01.01.2019**.
10. Pre-Bid meeting will be held at **1000 hrs on 24.08.2018** at **1st Engineer Services Regiment, Army Cantonment, Panagoda**.
