PROCUREMENT OF GOODS

1. The Chairman Ministry Procurement Committee (MPC) of Ministry of Defence on behalf of the Secretary / Ministry of Defence now invites sealed bids from eligible and qualified bidders for the procurement of the under noted items for Special Task Force of Sri Lanka Police. The total period for the completion of deliveries of Items No. 02, 03 & 04 procurements will be **90 days** and the total completion period of Item No: 01 procurement will be **140 days** (20 weeks), from the date of awarding the contract.

2. Bidding will be conducted through National Competitive of Bidding (NCB) method and the source of funding is GOSL.
3. Interested eligible bidders may obtain further information from Accountant (Procurements) of Ministry of Defence, No: 15/5, Baladaksha Mawatha, Colombo-03 on Tel No: 011-2390719, Fax Number: 011-2390720, email: procurement@defence.lk and inspect the Bidding Documents at the address given below from 0900 hrs. to 1500 hrs. on any working days except on Public & Bank Holidays from 27.05.2019 till prior to the date of closing/opening of bids mentioned above.
4. Qualified bidders shall possess legal right for the above procurements. The Bidder should produce a copy of the Certificate of Registration of a Firm issued under Business Name Ordinance (Chap. 149) incorporated by Business Names Statute No. 4 of 1990 and a copy of the Particulars of Directors Act No: 17 of 1982 (Form 48). The Bidder shall also submit the original of registration issued under Public Contract Act No. 03 - (PCA 03) of 1987 with the bid. **The PCA 03 should be produced at the time of purchasing the bidding documents.** The Bidder shall not have a conflict of interest and bidder's name shall not be included in the list of debarred firms at the National Procurement Agency/Commission. A margin of preference for eligible locally produced goods offered shall be applied. Additional details are provided in the Bidding Documents.
5. A complete set of Bidding Documents in English language may be purchased by interested bidders from the Procurement Unit of Ministry of Defence at No. 15/5, Baladaksha Mawatha, Colombo 03 from 0900 hrs, to 1500 hrs, on any working days from 27.05.2019 until prior date of opening of bids on the submission of a written application **with PCA 03 Form** to the Accountant (Procurements) of Ministry of Defence and upon payment of a non- refundable fees mentioned above on behalf of Secretary / Ministry of Defence. The method of payment will be in cash.
6. Bids in duplicate (Original/Duplicate) must be delivered to the address below **at or before the closing time of each procurement on each day mentioned in the above table.** Late bids will be rejected. Bids will be opened soon after closing of bids in the presence of the bidders or their representatives who choose to attend in person at Conference Hall at Ministry of Defence, 15/5, Baladaksha Mawatha, Colombo 03 **on the dates and times mentioned in above table.** The representatives who will attend on behalf of the bidder should produce an authorized letter from the organization.
7. Bids shall be validity for the period 91 days as mentioned in the bidding documents.
8. All bids shall be accompanied by a Bid Security and it shall be;

- i. Issued by any Commercial Bank operating in Sri Lanka and approved by the Central Bank of Sri Lanka
 - ii. In favour of Secretary / Ministry of Defence
 - iii. At the amounts mentioned above.
 - iv. In the form include in Section 09 of the Bidding Documents, an unconditional on demand bond and shall be valid 119 days as mentioned in the bidding documents
9. The decision taken by the Procurement Committee will be the final and the Purchaser reserves the right to make any amendments on Financial Regulations and Treasury Circulars issued periodically.
