The method of payment of the non-refundable deposit **will be in cash**. The Bid shall be valid up to **02nd February 2026**.

3. Completed bid proposal must be couriered/ delivered to the Accountant (Supply) address below, marked with Tender Identification Number on or before the stipulated time and date mentioned in above **para 1** and late bids will be rejected. Bids will be opened immediately after the closing of the bids in the presence of the bidders/ bidders' representatives who choose to attend the Bid Opening, in person at the address below as per the referred time and dates mentioned above. No bidder or his representative will be permitted to attend the bid opening after the bid closing time.

All prospective bidders shall submit a **Bid Security** in the form of an irrevocable and unconditional **Bank Guarantee**, en-cashable upon the first written demand, for the value and period specified in **Para 1** above. The Bid Security must be issued by any commercial bank operating in Sri Lanka and approved by the **Central Bank of Sri Lanka**. It should be addressed to the **Secretary, Ministry of Defence**.
