01. Purview

Providing Guidance at the national level towards a strategic approach with sustainable investment to ensure effective people-centered service delivery and economic and social empowerment to create a secure country by eradicating poverty.

02. Subjects and Functions

Directing the below mentioned Statutory Boards and Entities, as well as Task Forces in pursuit of the anticipated targets, their supervision and monitoring in line with the Policy Statement; “Vistas of Prosperity and Splendour” and based on the National Policies being implemented thus enlisting the assistance of the above Task Forces and in co-ordination with the concerned Ministries and in compliance with the applicable Rules and Regulations.

03. National Priorities

1. Coordinating and implementation of activities in relation to the subject areas of all Ministries with the Presidential Task Forces on National Security, Preventing the Risk of the Spread of Covid-19 Pandemic, Eliminating Drugs, Archeological Conservation, Education Reforms, Eradicating Poverty and Economic Revival.
2. Expanding local and foreign investment facilities for export and import substitute productions benefiting all parties thereby eradicating poverty through national development programme spelt out in the policy statement: "Vistas of Prosperity and Splendour"
3. Expanding other development centres required for the overall national economic development by developing Colombo, Hambanthota, Jaffna and Trincomalee as multifaceted national and international centres and Kandy, Anuradhapura, Gampaha, Ratnapura, Galle, Badulla, Mannar, Batticaloa and Kurunegala as national centres.

1.0 Minister of Defence

01. Purview

Ensuring the national security, first and foremost safeguarding the aspirations of the people of Sri Lanka as a unitary sovereign state.

02. Subjects and Functions

1. Providing policy guidance to relevant State Ministry, and formulating policies in relation to the subject of Defence, in conformity with the prescribed Laws, Acts and Ordinances, implementation of projects under the national budget, state Investment and National Development Programme, and formulating, implementing, monitoring and evaluating policies, programmes and projects, related to subjects and tasks under below-mentioned Departments, State Corporations and Statutory Institutions for the creation of a "Secured country" based on the national policies implemented by the government, and in line with the policy statement "Vistas of Prosperity and Splendour".
2. Initiating necessary measures to ensure National Security.
3. Implementing all actions necessary to rid the country of crime, drugs, money laundering and corruption while ensuring military security as well as state security, cyber security, food security.
4. Creating a secure environment in the country that facilitates foreign and local investment opportunities, as well as state and private economic activities.

03. Special Priorities

1. Control of internal riots, terrorist activities and protection from external influences
2. Prevention of illegal smuggling of goods and services in violation of maritime boundaries
3. Creation of a country free from drugs by working jointly with the relevant Presidential Task Force for prevention of the influx of drugs into the country, control of the drug menace, prevention from falling prey to drugs, rehabilitation of those addicted to drugs.

5. Strengthening institutional structures by coordinating risk management centres and relief service centres for early identification of risks related to natural disasters, disaster prevention, disaster mitigation and efficiently restoring affected parties.
6. Strengthening the Department of Meteorology with state-of-the-art technology and knowledge to accurately forecast disaster situations.
7. Developing a “National Disaster Database” comprising disaster affected areas, disaster vulnerable areas, persons, properties, businesses and agricultural lands affected by disasters.

02. Subjects and Functions

Creating people-centric economic and social development by directing, supervising and monitoring the below mentioned Departments, State Corporations and Statutory Organizations, as well as Presidential Task Forces towards achievement of anticipated targets in line with the Policy Statement: “Vistas of Prosperity and Splendour” and based on the National Policies being implemented, enlisting the assistance of the above Presidential Task Forces, and in coordination with the relevant ministries and in compliance with the applicable rules and regulations.

03. Special Priorities

1. Expansion of digital governance using information technology as a tool for providing efficient and people-centered services and knowledge exchange by simplifying the process of government machinery and market sectors.
2. Installing of international e-commerce and international electronic payment systems.
3. Establishment of a countrywide high speed data exchange system and related mobile network system.
4. Development of new laws and institutional framework for data protection, cyber security and intellectual property rights.
5. Introducing the legal system and regulatory framework required for digital governance and institutional structure, highlighting Sri Lanka’s uniqueness in the sectors of environmental sensitivity, information technology, knowledge and skills, health, tourism and sports.
6. Transforming to a technology enterprise economy by expanding enterprise development technological infrastructure and related services to expand the export contribution of the technology sector and the knowledge and professional service contribution of the national economy.
7. Establishment of Techno Parks to create high income generating jobs for the youth through transition to technology focused investments, businesses, entrepreneurship and allied service industries.

01. Purview

Ensuring public security and maintaining law and order by creating a conducive environment for all citizens to live freely without fear or suspicion

02. Subjects and Functions

Formulating policies in relation to the subject of Public Security in conformity with the prescribed Laws, Acts and Ordinances, implementation of projects under the national budget, State Investment and National Development Programme, and formulating, implementing, monitoring and evaluating policies, programmes and

projects, related to subjects and tasks under below-mentioned Departments, State Corporations and Statutory Institutions for ensuring public security based on the national policies implemented by the Government, and in line with the policy statement "Vistas of Prosperity and Splendour".

03. Special Priorities

1. Improving the service standards of the Sri Lanka Police with the objective of ensuring public safety.
2. Strengthening the Civil Security Department for the security and welfare of rural communities.
3. Implementing the programme with religious centers, social organizations and public and private sectors to rid the society from the menace of drugs at the community level as well as for children in schools and educational institutions, public and private work places.
4. Take necessary measures to prevent extremism and terrorism with the aim of ensuring internal security.
5. Control and suppression of robberies, murders, anti-social activities and crimes to keep public life safe.
6. Maintaining the necessary care for all citizens of the country, especially for women and children, to live their lives freely.
7. Reorganizing and modernizing the Traffic Police using modern technologies and techniques to enforce a systematic traffic regulation system and legal framework in order to prevent disorderly use of vehicles on roads, road accidents, deaths, injuries and hospitalizations and irregular and careless driving, violations of lane rules and road signs, as well as to reduce traffic congestion, especially in urban areas, caused by irregular driving and roadside parking.
8. Directing to the Multipurpose Development Task Force for on Poverty Alleviation as well as other development activities to increase the employment and livelihood contribution of poor families for multi-purpose development activities.
