- If the residence has changed, the Grama Niladhari certificate should be submitted to prove it.
- If over 65 years of age, you must submit a medical certificate (Form "H") to prove physical fitness. (download from www.defence.lk)
- A copy of the National Identity Card and the last license obtained should be submitted.
- When renewing this firearm license, the license should be renewed from the District Secretary of the resident district and the police recommendation should be obtained from the police jurisdiction of the resident district.
- If the relevant land is located outside the residential district / Divisional Secretariat, a report on damage to the crops/livestock should be obtained from the Grama Niladhari / Agricultural Research and Production Assistant / Agriculture Instructor of the Divisional Secretariat of the district to which the land belongs and attached to the application.
- The completed application form should be handed over to the District Secretary.
