**Request for Renewal of Licenses for Firearms Issued to the persons for the Protection of
Agriculture/Cultivation and Animal Husbandry – Year 2026**

Instructions:-

- A separate application should be filled out for each firearm.
- In case of a change of residence, a “Grama Seva” Certificate should be submitted to prove it.
- The medical certificate which denoted by “Form H” should be submitted to prove the physical fitness of those whose age is more than 70 years. (can be downloaded from www.defence.lk)
- Copy of National Identity Card and copy of the License obtained for the last time should be submitted.
- The license should be renewed by the District Secretary in the residing District, and the Recommendation of the Police is also should be obtained from the police jurisdiction of the District of Residence.
- With reference to the filling of Part III of the application, If the relevant land is located out of the District/Divisional Secretariat of residence, a report regarding the damage occurred to the cultivation/animals, should be obtained from the Grama Niladhari/ Agriculture Research and Production Assistant/Agriculture Instructor of the Divisional Secretariat in the District that the land belongs to, and it should be attached to the same application.
- Duly completed application should be submitted to the District Secretary in the area of the residence.
- The license fee is Rs.100.00 and it should be paid to the District Secretary.
- In case where the firearm owner's main livelihood is not agriculture, it must be ensured that action is taken in accordance with section 16 of Circular 01/2025 to use the firearm under a watcher's license.
- Grama Niladhari's certificate for the verification of employment.
