## Supply, Installation, Testing and Commissioning of Stage Lighting System and Motorized Fly Bar System for **Auditorium Building of KDU**

1. The Chairman, Ministry Procurement Committee, Ministry of Defence on behalf of the Vice Chancellor, General Sir John Kotelawala Defence University, Ratmalana now invites sealed bids from eligible and qualified bidders for Supply, Installation, Testing and Commissioning of Stage Lighting System and Motorized Fly Bar System (Contract No MOD/KDU/02/2022) as described below.

The Work consists of Supply, Installation, Testing and Commissioning of Stage Lighting System and Motorized Fly Bar System for Auditorium Building of General Sir John Kotelawala Defence University at Rathmalana.

Location of Project: General Sir John Kotelawala Defence University at Rathmalana.

The construction period is 180 days.

- Bidding process will be conducted through National Competitive Bidding (NCB) Procedure.
- In order to be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements
  - Bidder shall consider the requirement under the Public Contract Act No. 03 of 1987 and few important extraction of the Act as follows. "Any person who acts as an agent or sub-agent, representative or nominee on behalf of any
    - bidder shall register himself and such public contract in accordance with the section 10 and shall furnish to the registrar the particulars required to be furnished under section 6." "Where any person is an agent, sub-agent, representative or nominee for or on behalf of a
    - bidder, he shall first produce a certificate of his appointment as agent sub-agent, representative or nominee to the registrar before he registers himself and the public contract under this section" Bidders are advised to present the payment receipt or registration certificate before c.
    - purchasing the bidding document, according to the public contracts Act No 3 of 1987" if relevant.
  - ii. The bidder shall have manufacturer authorization in Sri Lanka for either stage light fixtures or motorized fly bar systems control components.
  - iii. The bidder shall have successfully completed and handed over 2 Numbers of Project in similar nature (minimum 400 seating capacity auditoriums) within last 10 Years. iv. The Bidder shall be a local agent/supplier for the light fixtures, control consoles, fly bar motors and
  - motor controls. Qualification requirements to qualify for contract award include:
- Average annual value of construction work performed in last Five years shall be not less than
  - Rs. 350 million. Audited Statements of last 05 years should be submitted along the bid document.

Experience as a contractor in successful completion of at least one project with a value of

- Rs.110 Million with a similar nature and complexity during last 5 years and shall submit Completion Certificates. The minimum Amount of Liquid Assets or credit facilities, net of other contractual
- commitments and exclusive of any advance payments which may be under the contract, shall be not less than Rs. 90 million. Interested eligible bidders may obtain further information from
