2. Obtaining the Applications

- b. A set of applications consist of following components.

- 3. The detailed category list which consists of approximately 46 pages

3. Paying the Category Charges

- a. Rs. 1825/= will be charged from the Local Suppliers for each category.
- b. Foreign Suppliers will be charged US\$ 18 for each category. When paid through a Local agent, the Local agent shall pay Rs 5750/ = per category.
- c. Above category charges for registration for the year 2025 may be credited to Account No. 7040119 maintained at the Taprobane Brunch of the Bank of Ceylon through any Branch of Bank of Ceylon. The Secretary of Defence should be the beneficiary for all payments. It is compulsory to mention "Suppliers Registration Category fee 2023" as the reason for deposit in the deposit slip by the applicant. (Money should not be deposited through Automatic Cash Deposit Machines as "Suppliers Registration Category Fee 2025" and it would be difficult to identify the deposit and applicants are advised to refrain from depositing money through Automatic Cash Deposit Machines).
- d. Foreign Suppliers (In the case of unavailability of a Local Agent) should also use the Swift Code to credit the payments to the Bank of Ceylon instead of above for the year 2025.

- f. Both Local and Foreign Suppliers should complete the payment of category charges during the period from 07.10.2024 up to 08.11.2024. Ministry of Defence will not be responsible for the payments made after 08.11.2024.
- 4. There is no refunding of category fee paid by an applicant. Applications can be rejected for not submitting certain information under any circumstance or marking the incorrect categories due to negligence of the applicant. Even on such an instance, the category fees shall not be refunded.
