1. The Chairman, Ministry Procurement Committee (MPC) of the Ministry of Defence on behalf of the Secretary, Ministry of Defence (MOD) now invites sealed bids from eligible and qualified bidders for purchasing of under mentioned items for the CEFAP Unit of Sri Lanka Navy.

2. Bids are invited from Local Manufactures, Manufactures / Foreign principals through Local Agents, Import & Supply.

3. International Competitive Bidding (ICB) procedure and the project will be financed by the Sri Lanka (GOSL) funds. Agreed conditions shall govern by the Sri Lankan Procurement Guidelines and Financial Regulations.

4. Financial statements, past performance reports for the last 3 years, receipt for payment made for the purchase, bid document and authorized standard certificates for the attorney's license must be submitted for this call for bids.

5. The bid submission under this tender must be valid to **13.07.2026**.

6. Bids must be accompanied by a bid security valid up to **07.09.2026** and should be addressed to Secretary Ministry of Defence. The bid security should be issued by a commercial bank operating in Sri Lanka which is approved by the Central Bank of Sri Lanka in its original form (on the original letter head of the bank), unconditional, irrevocable and on demand. The amount of the Bid Security shall be **LKR 7,000,000.00 (Seven Million LKR)** as prescribed in the procurement Guideline 2024.

7. Dates and time of issuing, submission and closing of bidding documents are as follows and respective bidders or authorized representatives could participate in this bid opening and delayed bids will be rejected.
