

# INVITATION FOR BIDS

## MINISTRY OF DEFENCE

### BID FOR DESIGN, SUPPLY AND INSTALLATION OF INFORMATION COMMUNICATION TECHNOLOGY SYSTEM (ICTS) FOR BLOCKS 01 & 02 OF DEFENCE HEADQUARTERS COMPLEX AT AKUREGODA

Contract No: DHQC/ICT/1&2/2020

1. The Chairman, Ministry Procurement Committee (MPC) of the Ministry of Defence now invites sealed Bids from eligible and qualified Bidders for Design, Supply and Installation of Information Communication Technology System (ICTS) For Block 01 & 02 of Proposed Defence Headquarters Complex at Akuregoda Road, Pelawatta, Battaramulla and as described below and estimated to cost LKR 350 Million.

*The work consists of supply, installation, configuration and maintenance of all the works in Local Area Network Switches and PABX System (LANS & PABX), Network Operating Center (NOC), CCTV IP Surveillance System (CCTV/IPSS), Door Access Control System (DACS), IP Television System (IPTVS) and Master Clock System (MCS) of Block 01 & Block 02 of Defence Headquarters Complex at Akuregoda, Sri Lanka.*

2. The Construction period is 270 Days.
3. Bidding will be conducted through National Competitive Bidding Procedure.
4. To be eligible for the contract award, the successful bidder shall not have been blacklisted. Bidders shall have Construction Industry Development Authority Grading EMI in the Specialty of Electrical and Mechanical Services (EM1) Under subspecialist area on Telecommunication and Information Technology Systems, Security Systems and Pipe Music Systems (ELV).
5. Other minimum Qualification requirements to qualify for contract award shall be:

(ii) Experience in Design, Supply and Installation within last ten years. (2010, 2011, 2012, 2013 & 2014, 2015, 2016, 2017, 2018 & 2019)	At least 3 nr. Information Communication Technology Systems successfully completed within last 10 years. Minimum value of one (1) Number of such system shall not be less than LKR 85 million. Information Communication Technology Systems. Evidence should be provided.
(iii) The minimum amount of liquid assets and/or credit facilities (after setting apart for other contractual commitments) and exclusive of any advance payment which may be made under this Contract	Not less than LKR 110 million. Evidence should be provided.
(iv) All the brands/makes proposed by Bidder shall have minimum of three (03) years' service history in Sri Lanka or ten (10) years internationally. Proposed products should not be banned products in world ICT/ELV market.	Compulsory. Bidder should provide documentary evidence/ letter from the manufacturer or local agent.
(v) All brands and models proposed by Bidder shall have product life time (End of Life) of 05 years ahead from the date of Bid opening.	Compulsory (should produce written evidence from manufacturers with the bid).
(vi) The proposed solutions shall be enterprise comprehensive solutions which should not base on any open source technology/ freeware	Compulsory (should produce written evidence from manufacturers with the bid)
(vii) Key staff shall consist with certified engineers of proposed products of PABX, LAN Switches and Firewalls.	Compulsory (Evidence should be provided.)
(viii) Manufacturers/Local Agents Authorization shall be given to the bidder to installation of equipment proposed for ICT systems.	Compulsory (should produce written evidence from manufacturer/ Local agent with the bid).
(ix) Category of equipment/Product Ranges quoted should have been deployed in similar environment/ industry/ forces globally with one similar installation running for the past 3 years.	Compulsory. (Should submit the certified evidence from manufacturers/local agent with the bid).
(x) Availability of local office or locally registered agent in Sri Lanka for the any query of the installed system within warranty period.	Compulsory. (Should produce written evidence from manufacturers/local agent with the bid).
(xi) OEM/Manufacturer needs to have a 24x7 Technical Assistance/Help Centre for the products of Local Area Network, PABX, CCTV system and DACS system.	Compulsory (should produce written evidence from manufacturers with the bid).
(xii) Major components interfacing the existing systems such as LAN Switches, PABX/ Voice Gateways, CCTV system, DACS system etc. shall be demonstrated and pass field trials. (Proof of Concept).	Compulsory

6. A complete set of Bidding Documents (except Section I and III of Volume 1A) in English language may be purchased by interested bidders on the submission of a written application to Accountant (Procurement), Ministry of Defence, No. 15/5, Baladaksha Mawatha, Colombo 03 from 14<sup>th</sup> December 2020 until 04<sup>th</sup> January 2021 from 09.00 hrs. to 15.00 hrs. during a working day upon payment of a non-refundable fee of LKR 40,000.00 (Sri Lankan Rupees Forty Thousand). The method of payment will be Cash or Bank draft drawn in favour of Ministry Procurement Committee (MPC), Chief Finance Officer (1), Chief Accountant's Office (Ground Floor), Ministry of Defence, No. 15/5, Baladaksha Mawatha, Colombo 03.
8. A pre bid meeting will be held at 10.00 hrs. on 23<sup>rd</sup> December 2020 and a site visit will be held on same day after the pre bid meeting at the Project Management Unit of Defence Headquarters Complex site at Akuregoda Road, Pelawatta, Battaramulla.
9. Bids shall be delivered to the address below or shall be deposited in the Bid box placed at the address below on or before 14.00 hrs. on 05<sup>th</sup> January 2021. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
10. Bids shall be valid up to 03<sup>rd</sup> May 2021 (119 Days after the date of opening of Bids, including bid open date).
11. All bids shall be accompanied by a "Bid-Security", of Sri Lankan Rupees Four Million (LKR 4,000,000.00) obtained from a bank operating in Sri Lanka approved by the Central Bank of Sri Lanka, in the form of an unconditional and on demand bond and shall be valid up to 31<sup>st</sup> May 2021 (147 Days from the date of opening the Bids including bid open date). Beneficiary of the Bid Security shall be Secretary, Ministry of Defence.
12. Bidders are strongly advised to present the registration certificate under the Public Contracts Act No. 3 of 1987 (when relevant), with the Bidding Document.
13. Bidders are advised to inform in writing, to the Chief Accountant Ministry of Defence, the Name and the NIC/Passport Number of the individual who is participating at the tender opening at least prior to three (03) working days of the bid opening.
