Registration on Electronic Government Procurement (e-GP) System

As you are aware, the e-GP Secretariat of Ministry of Finance Economic Stabilization and National Policies is developing and implementing the Electronic Government Procurement (e-GP) System in Sri Lanka to be used by all Government Procuring Entities for procurement of Goods, Works and Services. The URL to access e-GP system is www.promise.lk.

With reference to the Public Finance Circular No 08/2019 on Implementation of the electronic Government Procurement (e-GP) system in Sri Lanka, Government Procuring Entities are required to request all suppliers in the Annual Supplier Registration to register in the online Government procurement platform (promise.lk).

Ministry of Defence will start using the Promise e-GP system for Goods procurement under shopping procurement procedure. Requesting quotations/bids through this system can be obtained only from registered suppliers after 15th of February 2024 and we observed that your organization has not yet registered in this system yet. If you are not registered under Promise e-GP system, you will not get an opportunity to submit quotations/bids after 15th of February 2024 under shopping procurement procedure.

Therefore, please do register in Promise e-GP system by 15th February 2024 if you wish to continue as a supplier with our organization.

Please pay attention to following requirements when you register in promise.lk

- 1. First refer the "Vendor User Guide" which is attached separately for you to understand how to register and submit quotations in the e-GP system.
- 2. Use the Help Desk no +94-11-215-1467 if you are unable to do the activities after referring the User Guide.
- 3. You need to upload a PDF soft copy of your Business Registration at the time of registration.
- 4. You are required to pay Rs 5000 as the registration fee using a credit/debit card. Cash or cheque payments are not acceptable.
- 5. E-GP Secretariat will take one working day to accept your registration and then you receive an email/SMS mentioning your password to log in to the promise system
