All the Brands / Makes shall have minimum of 05 years' service history in Sri Lanka or country of origin.

Bidder shall provide 10 years guarantee for availability of spare parts, software and accessories from manufacturer.

There shall be a local office or locally registered agent in Sri Lanka for the any query of the installed system within warranty period
